

Mapendo children's tales Prize

Contest rules

FIRST

A unique modality is established and it is addressed to authors aged more than 16.

SECOND

The tales must be originals and unpublished without having received previously no prize or consolation prize in any other national or international contest. They will have to be written in Spanish or Catalan and its length will not be larger than two pages written in just one side and double-spacing.

The subject will be the water, as an element of encounter, communication and interconnection among cultures. An element that is a part of Nature and that has allowed civilizations development. Water is necessary for crops, it changes the environment and, besides, it has its own inner world, ways of life and systems that offer us a different and new vision in relation with our natural habitat: the land. The need of preserving this rich world, with its own keys and ways to work, favors us to wide our point of view and allows explaining in a metaphorical our capacity of entering into other worlds. This vision of the water connects with our Foundation values: the acceptance of the difference, the empathy for the other one, the collaboration in an equality level and the respect for Nature, values that should be also transmitted in the context of the tales participating in the contest.

THIRD

Originals will be sent by email to:

The tales must be sent in Word format, signed with a pseudonym. In the email must be included other Word document titled by the pseudonym and with the following information: Pseudonym, title of the tale, name, surname, DNI number, complete address, telephone number (mobile phone if possible) as well as e-mail.

The delivery terms for originals will finish on July 11th 2011 at 11:00 h. (Barcelona time).

FOURTH

A unique Euros 1200 prize in cash* will be awarded as well as the publication of the tale illustrated by a designer as a part of Mapendo Collection, whose profits will be addressed to financing the cooperation with Mapendo House project. The tale will be published in Spanish and Catalan regardless the language it has been presented, so the Fundació will be in charge of the translation into the corresponding language.

All in all, the participation in this contest involves to assign the publication copyright to Fundació Privada Roger Torné, together with the distribution, public communication, transformation and translation, according to the Intellectual Property Legislation through the rules specified on the paragraph above as well as any other method, all of this with no

profit motive in mind, and for the maximum length allowed by the said Intellectual Property Legislation.

* The said price will suffer the reduction established in the *Reglamento del Impuesto sobre la renta de las personas físicas* in force.

FIFTH

The jury will be consisted of people related with Fundació Privada Roger Torné. The jury decision will be published on July 25th 2011 on Facebook page and web page of the Roger Torné Foundation and the delivery of prizes could take place during a public ceremony with the jury attendance and the winner with his/her parents or guardian company-if necessary- who will be notified when the decision is taken. Roger Torné Foundation will not be required to pay for the travel of the winner to Barcelona.

The jury is authorised to leave the prize void.

SIXTH

If the participant is under age, it is essential for the parents or guardians to attach, together with the original tale and rest of personal data, and signed authorisation (see [Attached I](#)) expressing their approval, without reservation, to the specifications on the contest rules.

SEVENTH

The fact of taking part on the contest involves the acceptance of the rules.

EIGHTH

According to the article number 5 appearing on Spanish *Ley Orgánica 15/99* dated on December 13th, we inform that all personal data obtained through the participation on the contest will be added to a file which is Fundació Privada Roger Torné responsibility, whose purpose is the administration of the programmed cultural activities. The necessary data requested by the media will be delivered and they can be published on the municipal Web. All of them will be treated according to the protection data rules in force. All those interested will be able to practice the access rights, rectification, modification and opposition addressing themselves to Fundació Privada Roger Torné.
