

1st children drawing contest promoted by Fundació Privada Roger Torné

Contest rules

FIRST – SUBJECT MATTER

With a drawing and an explanatory sentence, kids will have to draw an answer to the following question: "How would you paint the air?". Thus the pieces received in the 1st children contest will be connected with our story subject [iPintar el aire!](#)

It is essential that each drawing has an innovative explanatory sentence answering to the question above. If, due to the kid age, he/she cannot write the sentence by him/herself, an adult can write it and attach it to the drawing. The format and technique used are free will.

SECOND – CATEGORY AND PARTICIPATION

There is only one established category addressed to kids aged between 3 and 12.

THIRD – PLACE AND PRESENTACION PERIOD

The delivery terms for original drawings will expire on November 24th 2009 at 13:30 hours

FOURTH – METHOD OF PRESENTATION

Each kid, under previous parents or tutor authorisation (see [Attached I](#)), will be allowed to take part with just one drawing which will be delivered together with an explanatory sentence written in a separate sheet of paper. A closed envelope must be enclosed containing the authorisation (see [Attached I](#)) where the parents or tutor signature appears and specifying complete name, age, address, telephone number, year the kid is in at school as well as name of the school.

FIFTH – PRIZES

The contest will assign the following prizes:

- A big batch of Pelikan products (Procolor watercolours box with 24 different colours, a griffix pencil, a griffix Sollker, a griffix pen, a fountain pen, a box with colours and a set of paints for canvas) will be given to the winner.
- A set of 10 books [iPintar el aire!](#) and also 10 books of the second Mapendo story that will be given to the winner school library.
- A Procolor box and 24 Pelikan watercolours for each one of the 9 contestants who reach the final.
- One copy of the book [iPintar el aire!](#) for the winner and for each one of the 9 finalist contestants.

SIXTH – JURY AND DELIVERY OF PRIZES

The jury will be consisted of two people connected with Fundació Privada Roger Torné. The jury decision will be published on the Fundació Privada Roger Torné web and on the blog [Pintar el Aire](#) on November 25th 2009.

The delivery of prizes will take place before of February 2010 during a public ceremony with the jury attendance and the winner who will be notified when the jury decision is made public. Fundació Privada Roger Torné will invite the winner together with one of the parents or the tutor to this celebration.

SEVENTH – RIGHTS OVER THE DRAWINGS

Fundació Privada Roger Torné will be able to use the winner drawing and sentence to design the Christmas Card. Likewise, the Fundació reserve the right to publish on the web and on the blog [Pintar el Aire](#) the 10 drawings reaching the final together with the author's name and the school he/she are attending.

All in all, the participation on the contest involves the Fundació Privada Roger Torné to be able to use the reproduction, distribution, public communication and transformation rights on the presented works (both drawings and sentences) appearing on the Intellectual Property Legislation through the methods specified in the previous paragraph, as well as any other method, all of it with no profit motive in mind, and during the maximum length allowed by the said Intellectual Property Legislation.

EIGHTH – ATTACHED DOCUMENTS

To take part on this children drawing contest it is essential for the parents or tutor that, together with the drawing and the rest of personal data, to include a signed authorisation (see [Attached I](#)) declaring they allow the participation of the kid and they accept the present rules giving their approval without reservations.

NINTH – DATA PROTECTION

According to article 5 appearing on Spanish Ley Orgánica 15/99 dated on December 13th, we inform that all personal data obtained through the participation in the contest will be added to a file which is Fundació Privada Roger Torné responsibility whose purpose is the administration of the programmed cultural activities. The necessary data requested by the media will be delivered and they can be published on the municipal Web. All of them will be treated according to the protection data rules in force. All those interested will be able to practice the access rights, rectification, modification and opposition addressing themselves to Fundació Privada Roger Torné.
